NOTICE TO SHAREHOLDERS



SHAREHOLDER TRUST HERITAGE DISTRIBUTION

At a Board of Trustee's meeting held on Saturday, March 23, the Trustee's declared a heritage distribution of **\$4.28 per share** to be issued on April 12. The Heritage Distribution amount was declared in accordance with the Trust's Distribution Policy based upon a contribution from SNAI that could have been distributed from SNA as a taxable dividend. Instead, this Heritage Distribution from the Trust will be **tax free** to SNAI Shareholders.

If SNA did not use the Trust for the distribution, the corporate taxes would have reduced the amount to just \$3.42 per share. Subtract about 12% for the personal tax, and that would end up being only \$3.01 per share. By using the Trust, SNA in this example, was able to boost the after tax distribution to you by 42%.

All Voting Shareholders 19 years of age or older are eligible to run for the Board of Directors.

Non-voting Shareholders may attend the annual meeting, but may not vote (a non-voting Shareholder is an heir who is not Alaska Native).

For proxy solicitation, a Shareholder mailing list with address labels are available at SNAI for a \$15 fee.

Shareholders must fill out a release form to receive the mailing list. This list must only be used for the stated purpose.

Each position is a three year term. Directors on the Board receive fees for meetings attended and should plan to attend four quarterly Board

business meetings, plus one strategic planning session each year.

Directors are entitled to receive travel and per diem payments if they travel for the meeting. These costs to attend Board meetings are paid by SNAI.

Teleconference/ Videoconference is always available for Board members when attendance in person is not possible.

ANNUAL MEETING

The 46th Annual Shareholders Meeting will be held in Anchorage on **Saturday, May 18, 2019**, at the Chesloknu Conference Room in the Dimond Center Hotel. A luncheon will be served. Please mark the date on your calendar.

ANNUAL REPORT AND PROXY FORM

The annual report, proxy form, the notice of the annual shareholders meeting and the information on the candidates who are running for election will be mailed to you on **April 18**. If you are interested in running for one of the three Board seats this year, please see below for more information.

BOARD OF DIRECTORS ELECTION

There are nine director positions on the SNAI Board and of those, three seats are up for election this year. These seats are currently held by the incumbents: Crystal Collier, Fred S. Elvsaas, Jr. and Tamara Bowdon.

Shareholders wishing to run for a Board of Directors seat this year must send in their Candidate Statement which includes a short statement and/or biography and a photo that will be placed in the April 18 Election Notice. It must be received by SNAI no later than the end of the business day of **April 11th**.

Please note that Shareholders can also be nominated from the floor at the Annual Shareholders Meeting.
